Redemptions from my investments for Ongoing Fees will normally be made no later than the 10th of each month. I acknowledge that where VAT is included the agreed rate will change if the underlying VAT rate changes. I confirm that I have received a personalised illustration that shows the effect of the fees agreed on my investments. I understand that my regular contributions will not change should the Adviser Fee agreement be terminated.
